

Terms and Conditions (T&Cs)

of Kletterinsel Fürstenfeld, R. Gladiator und W. Jensen GbR, Version: March 1, 2013

1. Each adult participant confirms by his/her signature that he/she has taken note of the rules of use and agrees with them. The parent/guardian of a prospective minor participant must read these rules of use and talk them through with the minor before the latter is allowed to climb in the high ropes course. In signing, the parent or guardian confirms to have read, understood and communicated the rules of use to the minor in question.
2. Using the high ropes course involves risks and is undertaken at your own risk. See point 6 regarding Kletterinsel Fürstenfeld's liability.
3. A prerequisite for participation is that the body weight of the participant does not exceed 120 kg and that he/she is not suffering from a mental or physical impairment which might act either as a threat to their own health or pose a danger to others. People with limitations may be able to participate, following consultation with the park manager responsible and under certain conditions which are to be clarified in each particular case. Pregnant women or those under the influence of alcohol or other drugs are not permitted to use the high ropes course.
4. All participants must complete the practical and theoretical safety briefing before entering the high ropes course. All instructions and decisions of the operator/supervisor are binding. In the event of a breach or a violation of the rules of use, of the instructions or of the safety requirements given by the operator/supervisor, the relevant participants will be excluded from visiting Kletterinsel Fürstenfeld. In the event of a breach or violation of safety requirements or instructions from the operator/supervisor, Kletterinsel Fürstenfeld assumes no liability for the resulting damages.
5. The safety equipment required for participation in the event will be provided by the operator. This equipment is the property of Kletterinsel Fürstenfeld. It is not transferable. The participant must take due care with these items. If they are damaged or are visibly abnormal, this should be reported immediately to safety personnel. In addition, the safety equipment issued by safety personnel is to be used only as directed by staff. If in doubt, a safety trainer must be consulted.
6. Kletterinsel Fürstenfeld is liable for personal injury within the scope of the law. The operator is not liable for loss, theft or damage to property. As regards damage to property and financial losses, Kletterinsel Fürstenfeld is only liable for the wilful misconduct or gross negligence of the operator or of those persons responsible for effecting the event or for its management. Kletterinsel Fürstenfeld is not liable for damages caused by our visitors to third parties.
7. The management team (represented by the park manager) reserves the right to discontinue operation due to safety reasons (fire, storm, thunderstorm, etc.). In this case, there will be no entitlement to a refund of the ticket price. If a participant ends his time at the site at his/her own request, there is likewise no refund of the ticket price.
8. Kletterinsel Fürstenfeld reserves the right to take photos, film and webcam images for promotional and information purposes anywhere on site. If a participant does not wish to have his/her image recorded, he/she must explicitly notify Kletterinsel Fürstenfeld.
9. Where permitted by law, the place of performance and payment is Kletterinsel Fürstenfeld's registered office. The law of the Federal Republic of Germany applies. The place of jurisdiction is Fürstenfeldbruck..
10. Severability clause: If any provision of these T&Cs is or becomes invalid, this shall not affect the validity of the remaining provisions. In the place of any invalid provision, a provision corresponding to the intention of the agreement will apply, or a substitute provision which is closest to this intention, as the parties would have agreed on to achieve the same end if they had been aware of the invalidity of the original provision. The same applies to loopholes.
